Sir,

This is regarding Compliance Reports submitted by **College of Engineering & Management, Kolaghat-721171, West Bengal** for the UG Engineering program which were accredited by NBA in Tier-II for academic years 2017-18 to 2019-20 and further accredited for one year i.e. up-to 30-06-2021 and whose validity of accreditation has expired on 30.06.2021.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II for the Academic Years 2017-18 to 2019-20 i.e. up to 30-06-2021 and were granted one year accreditation up-to 30/06/2021 on the basis of Compliance Report submitted by the Institute. The concerned Institutions have submitted Compliance Reports, but, the visit of Expert Team for data verification of the programs is pending because of the current pandemic situation due to Corona virus, the programs will be considered for further accreditation of one year i.e. up to 30-06-2022 after data verification of the programs internally on the basis of the submitted Compliance Reports. The data submitted by **College of Engineering & Management, Kolaghat-721171, West Bengal** in the Compliance Reports has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **College of Engineering & Management, Kolaghat-721171, West Bengal** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
